

Southern Sport Shooters Challenge

Rules and Procedures

The challenge is 12 different disciplined matches held once a month, at Tri State Gun Club. Starting in October 2022 and concluding in September 2023. The matches will be held on the 3rd Saturday on each month except when there is a scheduling conflict or a postponement has occurred, like a weather cancellation, see the match schedule. The matches are new shooter friendly as well as challenging for experienced competitors, ages from 13 and older are welcome to compete.

The challenge is formatted to give participating competitors points for competing in a match, based on the shooters finishing place in a division. Example, if there are 10 shooter in a division 1st place will receive 10 points, 2nd place will receive 9 points, 3rd 8 points and so forth. Even if a competitor is unable to finish the match they will receive 1 point for showing up and entering. After the last match in September 2023 the three shooters with the highest point's totals will be the Southern Sport Shooters Champions.

The champions will receive their awards at the Tri State Gun Club membership meeting in October 2023.

- 1st place will receive a custom built 10/22 style Lite Speed rifle.
- 2nd place will receive a \$450.00 gift certificate to Kaufman's Sporting Goods.
- 3rd place will receive a \$350.00 gift certificate to Kaufman's Sporting Goods.

Match information, i.e. safety rules, match procedures, equipment rules, results, points earned, and points overall, will be posted to the Tri State Gun Club web page. Emails will be sent out to all competitors who are on the Southern Sport Shooters email list. To get on the email list; email the match coordinator at tsgc.specialty@gmail.com, attend a TSGC general membership meeting, or participate in a challenge match.

Each match will have different division based on firearm type and configuration within each match type. There may be as many as six divisions per match. Competitors can only enter in and up to 2 divisions for points. In matches that have more than 2 divisions, with the Match Directors permission and time allowed a competitor may enter into other divisions and shoot 'not for score'. There is only one scheduled match that only one division per competitor can be entered, the Revolver only match in September 2023.

ALL matches will open registration the day of the match at 9:00 am, new shooter brief at 9:30 am, Match brief at 10:00 am, first shots to follow. Some matches will allow walk-on until the

last shot is fired, some matches will NOT allow walk-on. This information will be in the match procedures posted on TSGC web page (under the Specialty Match Tab).

The match entry fees are as follows;

- Tri State Gun Club Members- the first entry \$15.00, additional entries \$10.00 per division.
- Non Tri State Gun Club Members- the first division \$25.00, additional entries \$20.00 per division.
